The undersigned is aware of the risks of injury, death, & property damage that may result from, among other causes, the active or passive negligence of WAG, Inc. The undersigned is voluntarily engaging in dog agility as a recreational activity with the knowledge of the risks of injury, death, & property damage that may result from participation on dog agility.				
2. Release of Liability The undersigned releases WAG, Inc, from all liability to the undersigned, the "undersigned" representatives, guardians, successors, assigns, heirs, & next of kin for all liability, claims, damage, or demands for personal injury, death, or property damage, to the undersigned or the undersigned's dog or dogs, arising from or related to this agreement. This release includes, without limitation, any personal injury, death, or property damage caused by the active or passive negligence of WAG, Inc. The undersigned bears sole responsibility for any loss.

Knowing and Voluntary Execution The undersigned acknowledges that he or she has carefully read this agreement, understands its contents, & understands that this agreement includes an assumption of risk of WAG's negligence & a release of their liability.
